If the undersigned fails to repair such settlement, the Town of Kremmling may repair such settlement and all costs and expenses of said repair shall be paid by the undersigned. Upon failure to pay for such costs, the undersigned agrees if any legal action is necessary by the Town of Kremmling it shall pay all costs and expenses incurred including attorney fees and the costs of employees appearing to testify. The undersigned further agrees to indemnify and hold harmless the Town of Kremmling from any and all claims arising out of the excavation requested by this permit. There shall be no excavations in the town's right-of-way between November 1 through April 30. Exceptions may be made for emergencies or other special circumstances, reviewed on a case to case basis.
