Appointment of Chief of Police, Jesse Lisenby: Trustee Miller "aye", Trustee Sammons "aye", Trustee Pesch "aye", Erik Woog "aye", Trustees Bakke absent, and Trustee Prewitt absent. 4 "aye" votes, 0 "nay" votes. MOTION PASSED.

Appointment of Municipal Judge, Ronald Carlson: Trustee Miller "aye", Trustee Sammons "aye", Trustee Pesch "aye", Erik Woog "aye", Trustees Bakke absent, and Trustee Prewitt absent. 4 "aye" votes, 0 "nay" votes. MOTION PASSED.

Appointment of Town Attorney, Kelly PC, Melinda Culley: Trustee Miller "aye", Trustee Sammons "aye", Trustee Pesch "aye", Erik Woog "aye", Trustees Bakke absent, and Trustee Prewitt absent. 4 "aye" votes, 0 "nay" votes. MOTION PASSED.

# 4. Discussion & Action Item. <u>Appointment of Mayor Pro Tem:</u>

Mayor Howell explained the Board shall appoint a Mayor Pro Tem from the Trustees after each Regular Election. MAYOR PRO TEM SAMMONS reported he is happy to serve as Mayor Pro Tem again but if another Trustee is interested in the position, he would step aside. No other Trustees expressed interest in serving as Mayor Pro Tem.

TRUSTEE PESCH MOTION TO APPOINT Dave Sammons as Mayor Pro Tem. TRUSTEE MILLER SECONDS. Voice vote taken; 4 "aye" votes, 0 "nay" votes. MOTION PASSED.

# 5. Discussion & Action Item. <u>Airport Advisory Committee Appointment - Ashley</u> <u>Macdonald:</u>

Mayor Howell reported the Town Manager currently serves on the Airport Advisory Committee but the Mayor or a Trustee may serve on the Committee if they wish. No Board of Trustee members expressed interest in serving on the Airport Advisory Committee.

MAYOR PRO TEM SAMMONS MOTION TO APPOINT Ashley Macdonald to the Airport Advisory Committee. TRUSTEE PESCH SECONDS. Voice vote taken; 4 "aye" votes, 0 "nay" votes. MOTION PASSED.

**6. Discussion & Action Item.** Northwest Transportation Planning Region Appointment - Ashley Macdonald.

Mayor Howell reported the Town Manager currently serves on the Northwest Transportation Planning Region but the Mayor or a Trustee may serve on the Northwest Transportation Region if they wish. No Board of Trustee members expressed interest in serving on the Northwest Transportation Region.

MAYOR PRO TEM SAMMONS MOTION TO APPOINT Ashley Macdonald to the Northwest Transportation Region. TRUSTEE MILLER SECONDS. Voice vote taken; 4 "aye" votes, 0 "nay" votes. MOTION PASSED.

# 7. Discussion & Action Item. Chamber Liaison Appointment.

Ms. Serres explained no one currently serves as the Chamber Liaison, however, this appointment has been previously discussed by the Board of Trustees. She further stated that the Chamber Liaison would be the Mayor or Board of Trustees member that would attend Chamber of Commerce meetings and serve as the Liaison between the Board of Trustees and the Kremmling Area Chamber of Commerce Board. TRUSTEE PESCH reported he would like to serve as the Chamber Liaison. No other Board of Trustee members expressed interest in serving as the Chamber Liaison.

TRUSTEE WOOG MOTION TO APPOINT Trustee Pesch as the Chamber Liaison. TRUSTEE PESCH SECONDS. Voice vote taken; 4 "aye" votes, 0 "nay" votes. MOTION PASSED.

# 8. Discussion & Action Item. Library Advisory Committee Appointment - Teagan Serres.

Mayor Howell reported the Town Clerk & Treasurer currently serves on the Library Advisory Committee but the Mayor or a Trustee may serve as the Town representative if they wish. No Board of Trustee members wished to serve on the Library Advisory Committee.

TRUSTEE WOOG MOTION TO APPOINT Teagan Serres to the Library Advisory Committee. TRUSTEE PESCH SECONDS. Voice vote taken; 4 "aye" votes, 0 "nay" votes. MOTION PASSED.

## Local Liquor Licensing Authority

MAYOR PRO TEM SAMMONS MOTION to pause the Regular Meeting of the Board of Trustees and convene as the Local Liquor Licensing Authority at 6:55 PM. TRUSTEE MILLER SECONDS. Roll call vote was taken; Trustee Miller "aye", Mayor Pro Tem Sammons "aye", Trustee Woog "aye", and Trustee Pesch "aye". 4 "aye" votes, 0 "nay" votes. MOTION PASSED.

• Annual Renewal of the Grand Old West Hotel & Restaurant License at 106 Park Avenue.

Ms. Serres presented the annual renewal application for the Grand Old West Hotel & Restaurant License and explained a review of the application found the establishment is in good standing with the Colorado Secretary of State, they are current with sales tax, and the Kremmling Police Department did not report any issues directly related to the establishment's liquor license. The establishment has legal possession of the premises and there were no concerns during a visual inspection of the premises.
